## Ryan's Requests for Joint Medical Planning, Consent, and Documentation & Jennifer's Evasion Tactics

These exchanges (source: OFW) demonstrate a persistent struggle for Ryan to obtain timely consultation and necessary documentation for the children's medical care, often resulting in Jennifer resorting to threats or emotional avoidance.

Non-Response (followed by Deflection): Jennifer provided no response to this message seeking confirmation of her attempt to communicate about the scheduled visit, leading Ryan to assume her noncompliance. When she did respond later, Ryan rejected her claim of sufficient notice.
