

This table captures all correspondence located in the OFW Record from Ryan Egeland regarding Ada's strep, penicillin allergy, colonization status, or specific medical appointments he managed or sought information on, as well as Jennifer Egeland's responses. Jennifer's responses are categorized as either **responsive** if they addressed Ryan's question/concern or if -- **if not responsive** -- why the response was unhelpful to Ryan's communication or problem-solving objective.
